

<u>UCalgary Alumni Association Board of Directors:</u> <u>Role, Responsibilities, and Expectations</u>

Directors of the UCAA Board are required to:

- Be a member of the UCAA (you are a member by virtue of receiving a degree from UCalgary);
- Act in the best interest of the UCAA;
- Comply with the University's Code of Conduct and other applicable policies;
- Participate in orientation and ongoing education regarding the role and responsibilities of board members and the Board, and regarding the Board's strategic priorities; and
- Diligently engage in Board and committee work to help the Board fulfill its mandate and strategic priorities
- **Time Commitment**: Attend board and committee meetings throughout your term. You can expect to attend at least 5-7 board meetings each year, 4-5 committee meetings, and the Annual General Meeting. Board meeting dates are published with ample notice and you are expected to attend all meetings. Any absences are to be arranged with the UCAA Chair in advance, with no more than two absences in a year typically permitted.

Members of the UCAA Board are selected based on demonstrated involvement, support, and commitment to the University of Calgary, the UCAA, and its members. If selected, UCAA Board members will be asked to agree to fulfill, to the best of their ability, the responsibilities and expectations associated with Board membership. These include, but are not limited to:

- 1. **Board Knowledge:** Familiarity with the board governance documents, policies, and procedures.
- 2. **Meeting Participation.** Attend and actively participate in Board meetings including the Annual General Meeting. If unable to attend a Board meeting submit, in advance, a written response related to action items on the agenda. Review the board package prior to each meeting so you are informed and prepared for the topics to be discussed and motions to be passed.
- 3. **Committee Participation.** Serve actively on at least one Board standing committee and participate in committee meetings. If asked, be willing to serve as a committee chair or serve on an ad hoc (short-term/focused charge) committee of the UCAA Board. As opportunities arise, consider representing the Alumni Association on the Board of Governors, Senate, or search committees for University leadership positions.
- 4. **Financial Participation.** When 100% of board members make a philanthropic contribution, it sends a proud statement to the community, "We are behind the university every single one of us." It is important that each board member make their own proud, personal gift to the UCalgary fund of their choice in an amount meaningful to them.
- 5. **Community Outreach.** Become a representative and ambassador in your community for the University of Calgary and the Alumni Association. This task may involve meeting with faculty

- members and executive leadership of the University, talking with prospective students, meeting with other alumni, and attending events on behalf of the UCAA.
- 6. **Succession Planning.** Recommend potential UCAA Board and committee members to the Nominations and Assessments Committee.
- 7. **Program Activity Awareness.** Be familiar with the programs and activities sponsored, organized, and coordinated by the Office of Alumni Engagement and the UCAA. Attend Alumni Association and other university programs or activities and serve as brand ambassadors of the UCAA. Nominate and encourage others to make nominations for UCalgary Alumni Arch Awards.
